Spinneybeck leathers are made from the top 2% of the world's finest hides, inspected numerous times during production.

After tanning, all Spinneybeck leathers are drum-dyed, a time-consuming procedure which ensures color penetration throughout the hide. Then each hide is finished in the manner which will best bring out its individual character.

Spinneybeck leathers are all full-grain aniline drum-dyed products imported from Italy.

The following is a list of Spinneybeck leathers. Leathers are grouped into five price categories referred to as "grades." The selection of approved leathers varies by product. Please refer to the application approvals matrix for more information.

**Fabric Surfaces**

A regular maintenance program will significantly lessen soil and dirt build up or staining. Cleaning is particularly important in areas adjacent to air conditioning or ventilation systems. • Avoid excessive heat or moisture. Never allow fabric surfaces to become wet inside the core. Room temperature should be maintained 50-85 degrees; humidity between 20-50%.

- Avoid contact with sharp edges which could puncture the surface.
- Do not handle fabric more than necessary. Avoid bending or flexing the surface.
- Grease or oil should be wiped off immediately. Remove excess grease or oil by blotting. Use hot water and mild soap to remove any remaining residue.
- Whenever possible, clean only with warm water and mild soap. Use caution when applying cleaning agents, particularly those that contain alcohol, strong alkalis, or solvents. These ingredients may react to backing or adhesives used. Always test cleaning agents in an inconspicuous place first.

**Knoll Textiles fabrics**

See Knoll Textiles website for detailed cleaning and care instructions. Wipe all spills immediately. Brush and vacuum every three to four months. Use a foam upholstery cleaner as directed semi-annually or more frequently, if necessary. Try a hidden area to test for color fastness.






**Spinneybeck Leathers**

Leathers develop a patina with age. Wipe all spills immediately. Do not use harsh cleaners, wax or oils, which will clog pores. Periodically wipe with a damp cloth. See [spinneybeck.com](http://spinneybeck.com) for detailed cleaning and care instructions and to purchase leather maintenance kits and ink remover.

# Selling Policy

This Selling Policy supersedes all previous selling policies and is inclusive of Knoll, KnollStudio and Muuto. Prices, discounts and product offerings are subject to change without notice.

<b>Terms &amp; Conditions of Sales</b>	Sales by Knoll, Inc. or Knoll North America Corp. ("Seller") of Knoll Product Lines (hereinafter "Products") within the United States and Canada are made only on the terms which are contained in this Selling Policy. Seller hereby gives notice of its objection to any different or additional terms and conditions. This sale is expressly conditional upon Purchaser's assent to the terms and conditions set forth below. Additional terms and conditions may apply to KnollStudio and KnollTextiles orders. These terms and conditions may be modified or supplemented only by a written document signed by an authorized representative of Seller. These terms and conditions supersede any prior and/or contemporaneous agreements or correspondence between Purchaser and Seller. Written quotations expire thirty (30) days from the date of issuance and can be withdrawn by written notice anytime during that period. Where Purchaser and Seller have entered into the Knoll Electronic Terms and Conditions, all orders, acknowledgements, invoices and other business communications placed or transmitted in accordance with the Knoll Electronic Terms and Conditions shall be deemed to be in writing and signed and shall be valid for all purposes as if they were originated and maintained in documentary form.
<b>Ordering Information</b>	All orders must be in writing. The product pattern number(s) contained on Seller's order acknowledgement shall be the final expression of the order.
<b>Order Confirmation</b>	A purchase order is not binding on Seller until Purchaser has received Seller's order confirmation or acknowledgment.
<b>Pricing Policies</b>	List prices are subject to change without notice. List prices shall be those prices in effect on the date of receipt of a complete purchase order unless shipment is requested more than ninety (90) days after order entry in which case prices in effect on the date of shipment apply. List prices include specified freight costs. Unless specified in writing by Seller, no other charges are included in Seller's list prices.
<b>Taxes</b>	All sales, use, excise and other taxes applicable to the sale of the Products shall be paid by Purchaser. If Purchaser claims an exemption from any tax, Purchaser shall submit to Seller the appropriate exemption certificates.
<b>Terms of Payment</b>	Payment for one hundred percent (100%) of the net order amount (including any applicable shipping and handling fee) is due within thirty (30) days of the date of invoice, which is generally issued upon shipment. In case of any discrepancies, such as shortages, and Seller is notified in writing within ten (10) days of receipt of Product, only that portion may be deducted and the balance paid. For orders greater than \$100,000 net, a fifty percent (50%) deposit is due at the time of order placement, with the remainder due within thirty (30) days of the date of invoice. KnollStudio orders less than \$2,000 require payment for one hundred percent (100%) of the net order amount (including any applicable sales tax and charges for inside delivery, special packaging, etc.), due at time of order placement. For KnollStudio orders greater than \$2,000, a one-half (50%) deposit is due at time of order placement with the remainder (including any applicable sales tax and charges for inside delivery, special packaging, etc.) due prior to shipment. If, in the judgment of Seller, Purchaser's financial condition does not justify the terms of the payment, Seller may require full or partial payment in advance. Past due accounts shall be charged one and one-half percent (1.5%) per month, or the highest rate permitted by law, whichever is less, and will be added to the outstanding balance. In the event Purchaser defaults on payment, Purchaser shall be liable for all collection costs, including reasonable attorney's fees and costs.
<b>Changes and Cancellation</b>	Standard purchase orders may not be changed or cancelled, in whole or in part, without prior written consent of Seller. Changes may effect delivery dates. Expenses incurred because of changes shall be charged to Purchaser. In the event of cancellations, Purchaser will be liable for reasonable cancellation charges established by Seller. Orders for special Product, orders including "COM" (hereinafter defined) material and orders pursuant to expedited delivery programs, may not be canceled. QuickShip orders may not be changed or canceled without Knoll's authorization. In the event of Muuto order changes, 25% payment of original net order amount is required for changes incurring the week the order was entered. 100% payment of original net order amount is required for changes incurring the week the order is scheduled to ship. If Muuto is ordered on QuickShip, the QuickShip policy supersedes.
<b>Freight Prepaid</b>	For standard orders, freight is prepaid and included in the price of all Knoll Office and KnollStudio Products, except KnollTextiles and Muuto, within the 48 contiguous United States for orders placed with Knoll, Inc. and within Canada, excluding the Yukon, Northwest Territories, Nunavut and Newfoundland for orders placed with Knoll North America Corp. Packing is tested for rigorous motion and transportation but is not guaranteed to protect furniture from all conditions. If special packaging is required for any reason, please consult with your sales representative or dealer. Seller shall select the method of shipment and routing. Freight for all KnollTextiles orders is prepaid and added to the invoice. Freight for all Muuto orders must be specified at time of order placement and added to the PO.
<b>Delivery/Freight Charges</b>	Shipments outside the contiguous 48 United States and Canada shall be shipped F.O.B. Origin. For shipments outside the contiguous United States and Canada, Purchaser is responsible for the cost of freight from point of embarkation, including any handling and transportation charges incidental to loading at the point of departure and unloading at the final destination. Conditions beyond the control of Seller, including weather, available facilities and traffic conditions, may affect exact time of delivery. Seller shall not be responsible for specific carrier delivery date or time unless it has made a specific delivery commitment, in writing. Nonstandard methods of shipment and/or additional services are available upon request. Orders for QuickShip product shipping direct parcel or White Glove are subject to additional shipping and handling charges and must be paid by Purchaser. Purchaser will be billed for the differential cost of any special services in excess of standard surface carrier freight costs. Premium charges, at Purchaser's request, will be added for airfreight, exclusive use of vehicle and extra, export or special packaging. Accessorial charges will be added for inside delivery, extra labor, reassignment and redelivery. Partial shipments may be made and invoiced by Seller.
<b>Claims</b>	All shipments for Knoll Products within the contiguous United States and Canada are F.O.B. Origin. All risk of loss passes to Purchaser at time of delivery to carrier. Purchaser shall inspect all Products upon receipt and notify Seller within ten (10) working days after receipt of any damage or defects which are, or should be, apparent from an inspection of the Product and its packaging. Failure of Purchaser to notify Seller during the ten (10) working day period shall constitute acceptance of the Products and waiver of any apparent defects, errors or shortages. For all claims relating to Product damaged in transit or for any other claims relating to or arising out of the transportation of the Product, Purchaser must seek recovery from the carrier and Seller has no liability to Purchaser for such claims. Seller may, upon request, assist Purchaser with filing of such claims with the carrier, but Seller will not be liable for any of these transportation related claims.

All returned Products must be unused, in original condition and in the original Seller packing cartons. No refund or credit shall be given for damaged Products.
<b>Held Orders/Storage</b>	If Purchaser requests that an order be held or delayed, prices and terms and conditions in effect at the time of shipment shall apply. If Purchaser requests a delay after the time when Seller can defer production, Purchaser will be invoiced for the Product, payable in accordance with standard terms, when the order is ready for shipment. Seller may transfer the Product to storage, in which case all expenses incurred in connection with storage, including demurrage, preparation for storage, storage charges and handling shall be payable by Purchaser upon submission of invoices by Seller. Seller shall determine if the material is suitable to its manufacturing processes and meets any requirements of Underwriters Laboratories. If the COM is acceptable, Seller will then establish a price for using the COM or the Product in question. For a description of the procedures for submitting samples and testing, contact customer resources or your sales representative. Seller shall have no responsibility for the appearance, condition, performance, durability, colorfastness or any other physical attribute of the COM. Purchaser shall indemnify and hold Seller harmless for any damages, injuries or losses arising out of or related to use of the COM on the Product.
<b>Warranty</b>	Seller warrants to the original Purchaser only that the Products Seller manufactures and sells to Purchaser are free of defects in workmanship and materials, during the applicable warranty period set forth below. Warranty period set forth below is for 24-hour, 7 days a week, multi shift use (includes parts and labor to repair). Should any failure to conform with this limited warranty appear to a Product listed below during the applicable warranty period from the date of shipment, Seller shall, upon prompt written notice, repair or replace, at its option and costs, the affected part or parts.

This warranty does not apply to:

- Damage caused by a carrier other than the Seller.
- Normal wear and tear or acts or omissions of parties other than Seller (including user modification, improper use or installation of Products).
- COM or other third party materials applied to Products.
- Products not installed by or under the auspices of a Knoll Dealer.
- Dramatic temperature variations or exposure to unusual conditions.
- Changes in surface finishes, including colorfastness due to aging or exposure to light.
- Except as specifically noted above, textiles and upholstery supplied by *KnollTextiles* and Spinneybeck FilzFelt (consult current price lists for applicable warranties).

Natural variations occurring in wood, marble, and leather shall not be considered defects, and the Seller does not guarantee the colorfastness or matching of the colors, grains or textures, or surface hardness of such materials. The Seller also does not guarantee the colorfastness of fiberglass panel surfaces.

THE EXPRESS WARRANTIES CONTAINED HEREIN ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTIES OF MERCHANTABILITY AND FITNESS FOR PARTICULAR PURPOSE AND ALL OTHER WARRANTIES ARISING FROM COURSE OF DEALING OR USAGE OF TRADE.

The remedies provided above are the Purchaser's sole remedies for any failure of Seller to comply with its obligations regarding the workmanship of its Products. Correction of any nonconformity in the manner and for the period of time provided shall constitute complete fulfillment of all liabilities of Seller, with

- Combination of the Product with another product not furnished hereunder unless Seller is a contributory infringer.
- Any settlements of a suit or proceeding made without Seller's written consent.
